In exercise of the provision of Automatic Annual Increment under Section-3 of Schedule-III (SCHEDULE OF GENERAL CONDITIONS OF SUPPLY - 2006) of Tariff - 2006 notified vide Government's notification No. PVRS/W-256/95-96(Vol.II)/1756-67 dated 15th September 2006, the Electricity Tariff under Schedule-I and schedule of miscellaneous charges under Schedule-II have been enhanced by 5% (rounded off to the nearest 5 paise & nearest rupee respectively as under:-
