- 3) **Earnest Money Deposit:** Earnest Money @ 2.5% (two & half percent) of quoted value in the form of DD/IPO duly pledged in favour of The Executive Engineer (Elect.), Pasighat Electrical Division, Department of Power, Pasighat, Arunachal Pradesh. The Tendered quotation will not be accepted without Earnest Money.
- 4) Earnest Money Deposit submitted by the successful bidder shall be retained till satisfactory completion of delivery of the material.
- 5) **DELIVERY:** Delivery should be completed within 90 (ninety) days from the placement of the order. For delay in delivery, LD @1/2 % (half percent) per week of delay subject to a maximum of 5 (five) % of total order value shall be deducted.
- 6) **PAYMENT:** 90 % (ninety percent) payment will be released after receipt of the material in full and in good condition at Delivery Site against submission of bill. Balance 10 % (Ten percent) will be kept as Performance Guarantee for a period of one year from the date of receipt of materials. OR 100% (Hundred percent) payment will be released after receipt of materials on

submission of Performance Bank Guarantee equivalent to an amount of 10% (ten percent) of the total order value with validity period of 15 months from the date of delivery.

- 7) **F.O.R.:** Rates shall be quoted at F. O. R. Divisional Store Yard, Pasighat Electrical Division, Pasighat, Arunachal Pradesh.
- 8) **QUANTITY:** The quantity mentioned may vary at the time of placing order.
