**NOTICE INVITING TENDER**

The undersigned on behalf of the Governor of Arunachal Pradesh invites domestic bidding from the eligible contractors for execution of following works

Non-transferable bid documents shall be available in 3(three) parts namely: (1) Part-I-Containing Bid Guarantee & Bid Proposal letter, (2) Part-II- Containing Pre Qualification data & Deviation Statement & (3) Part-III-Containing Condition of Contract (Vol-1/2) and Technical Specification in 2(two) parts from the office of the undersigned i.e Executive Engineer(Elect), Roing Electrical Division, Department of Power, Roing on above specified details on all working days.

The proposed bidders shall have to apply for the bid document on contractor's/company's printed letter pad with details postal address, telephone No, Mobile No, Fax No, e-mail ID etc enclosed with the documents of qualification under the following general information and basic qualification requirements. General information & basic qualification requirement

1. Prospective purchaser of bid documents shall have to furnish letter of authority & proof of being an authorized representative of the bidder
2. Prospective bidder(s) shall have to furnished the following
  - i. Original copy of valid VAT Registration No. Excise Duty License, Service Tax Registration(if any), Manufacturer Certificate, Dealership Certificate wherever applicable
  - ii. Latest income Tax & Sale Tax Clearance Certificate from the competent authority.
  - iii. Documentary evidence that they executed similar nature of work with equivalent amount in a Single Order in the last three years which commensurate to tender package being purchased.

- iv. The bidders must have experience certificate under any Utility like PGCIL, State Power Utility having successfully erected at least 10 Kms of 33KV class or above voltage class of line during the last 7(seven) years as on the date of bid opening and which must be in satisfactory operation for at least 2(two) years as on the date of bid opening, *such certificate should be signed not below the rank of Executive Engineer*

OR

The bidder must be a manufacturer of 33KV or above class lattice steel towers, who must have designed, manufactured, type tested, supplied and erected such towers which must be in satisfactory operation for at least 2(two) years as on date of bid opening, *such certificate should be signed not below the rank of Executive Engineer.*

Or

The bidders must have experience certificate under any Utility like PGCIL, State Power Utility having successfully supplied and erected 33KV class or above towers which must be in satisfactory operation for at least 2(two) years as on the date of bid opening, provided the tower being offered are from manufacturer(s) who have designed, manufactured, type tested and supplied such tower of 33KV or above class which must be in satisfactory operation for at least 2(two) years as on the date of bid opening, such certificate should be signed not below the rank of Executive Engineer.

Or

The bidder must have successfully executed at least one Sub-Station or Switchyards of 33 KV class or above voltage having at least three circuit breakers bays, during the last 7(Seven) years as on the date of bid opening and which must be in satisfactory operation for at least 2(two) years as on the date of bid opening.

- v. The application for bid document accompanied with cost of bid document in cash or demand draft along with a set of atleast 2 copies of above supporting documents has to be addressed and submitted to the following address

- vi. The bid documents shall neither be sold nor accepted for opening through postal or courier service.
- vii. The Department of Power shall not be responsible for any form of delay in receiving the bid document in time and no extension of time shall be entertained on such account. The bid documents received after due date of opening will not be opened.
- viii. The bid guarantee (Earnest money) in the form of BANK GURANTEE tentatively shown above in the table shall have to be deposited along with the bid document in the prescribed format and manner described in the bid documents. This shall be excepted only in the form of BANK GUARANTEE and no other financial instrument.
- ix. Department of Power reserves all right to cancel/withdraw the bid in full or in part without assigning any reason for such decision and to place order in full or in part. Such decision will not incur any liability whatever on the part of Department of Power consequently.
- x. The bid documents should be properly indexed and pages be marked under the head contents in the bid document.
