ORDER

Consequent upon re-structuring of Department of Power into four Zones namely: a) Transmission, Planning & Monitoring Zone, b) Eastern Electrical Zone, c) Central Electrical Zone and d) Western Electrical Zone, headed by four Chief Engineers designated as;

- a) The Chief Engineer (Power), T P&M Zone,
- b) The Chief Engineer (Power), Eastern Electrical Zone,
- c) The Chief Engineer (Power), Central Electrical Zone and
- d) The Chief Engineer (Power), Western Electrical Zone,

by re-naming the earlier two posts of Chief Engineer (Planning and Monitoring) and Advisor (Power), respectively vide order No. PWRS/E-31/2010/998-1012, dated 20th March 2012 and PWRS/E-31/2010/1703-20, dated 19th April 2012, the Governor of Arunachal Pradesh is pleased to appoint the following Chief Engineers to **function as State Nodal Officer** for the subjects assigned to them as under in addition to the duties and functions as Chief Engineers of their respective zones:-

- A: Chief Engineer (Power), Transmission Planning & Monitoring (T P&M) Zone:**
- (i) All matters of State Transmission Systems (STS)
 - (ii) All matters on enforcement of Electricity Act, Rules and Regulations thereof.
 - (iii) Compilation of AOP/FYP of the Department.
 - (iv) All policy matter regarding service including imparting/conducting Training, Placement and Capacity Building .
 - (v) All matters of State Load Dispatch Centre.
 - (vi) All matters of Registration of Contractors and revalidation thereof.
 - (vii) All matters of Schedule of Rates, Specifications, cost-indexing and re-validation.
 - (viii) Any matter not assigned to any of the zones.
- B: Chief Engineer (Power), Western Electrical Zone(WEZ)**
- i) All matters relating to R-APDRP and Reform Programmes under Distribution System
 - ii) All matters relating to Commerce and Trading of Electricity.
 - iii) All matters on High Voltage Distribution Systems.
 - iv) All matters of Consultancy Services, Deposit Works, Internal Building Electrification and other miscellaneous distribution works.
- C: Chief Engineer (Power), Central Electrical Zone(CEZ)**
- i) All matters related to Rural Electrification, RGGVY and REC schemes.
 - ii) All matters related to NLCPR schemes.
 - iii) All matters related to NEC schemes.
 - iv) All matters of RIDF, Local Area development, Un-tied Fund.
- D: Chief Engineer (Power), Eastern Electrical Zone (EEZ)**
- i) All matters of budget, AOP of Distribution System
 - ii) All matters of Account and Audit viz; AG, CAG, PAC and Internal Audit.
 - iii) All matters of Performance Audit.
 - iv) All matters related to New & Renewable Energy (MNRE) and APEDA.
 - v) All matters related to SPA schemes.
 - vi) Compilation of details Accounts and Establishment of the Department.
 - vii) All matters related to FDR, Relief Natural Calamities and Disaster Management.
- E. Temporary General Provisions**
- The standing assets of State Transmission Systems (STS) and on-going STS projects would be temporarily with the respective Distribution Zones till further orders.

The Governor of Arunachal Pradesh is further pleased to order that the State Nodal Officers shall be responsible for co-ordination in conduct of meetings, acquisition of information and data from all the zones and their respective sub-ordinate offices, correctly compiling them and report or represent the Department as a single entity.
