**Eligibility Criteria for issue of Tender Paper**


Tender documents will be issued to approved and eligible contractors of Department of Power (A.P) and those of appropriate list of Telecommunication, Railways, Powergrid, NTPC, NHPC, NEEPCO, MES, etc provided they produce following documents:-

1. **Experience Certificate**:- The bidder must have experience certificate from any utilities like Department of Power (A.P) and those of appropriate list of Telecommunication, Railways, Powergrid, NTPC, NHPC, NEEPCO, MES of having successfully designed, manufactured, type tested and erected similar nature of works during the last 5(five) years as on the date of bid opening which must be in satisfactory operation for at least 2(two) years as on date of bid

opening. Such certificate should be signed not below the rank of Executive Engineer. Preference will be given to contractor(s) who have executed similar works in Arunachal Pradesh during the last 5 years.

2. The bidder must have satisfactorily completed similar works of magnitude specified below:-
  - 2.1 Three or more similar works costing not less than **Rs. 42 Lakh** in aggregate during the last 5(five) years.  
  
For the purpose of the clause similar works means the works of "**Supply, erection, installation, testing and commissioning of High Mast Lighting System**".
3. Attested copy of Valid VAT Registration No, Excise Duty License, Service tax Registration, Manufacturer Certificate / Dealership Certificate whichever applicable.
4. PAN Card / Latest Income Tax Clearance Certificate from the competent authority.
5. Pre-bid conference shall be held in the office of undersigned 4(four) days before the last date of submission of tender papers i.e on 15/03/2014 (10 AM to 1 PM).
