The Executive Engineer, Roing Electrical Division, Department of Power, Roing on behalf of the Governor of Arunachal Pradesh invites domestic bidding from the eligible/experience contractor/firms having successfully completed RGGVY project in the state of Arunachal Pradesh for "Construction of 33/11KV, 2x5MVA Power Sub Station at Deopani near Roing and Providing High Voltage Distribution System in Roing Township under Lower Dibang Valley District, A.P".

The bidder must be an individual firm having valid BIS certificate / preferably posses ISO 9001 certificate and having satisfactorily completed 2.5MVA, 33/11KV or above class sub station in last 7 (seven) years as on the date of bid opening and which must be in satisfactory operation for at least 2 (two) years as on the date of bid opening. Such certificate should be signed not below the rank of Executive Engineer.
2. Bidder must produce certificate having successfully completed RGGVY project in the state of Arunachal Pradesh. Such certificate should be signed not below the rank of Executive Engineer.
3. The average annual turn over of the bidders for the best three financial years out of last five (5) financial years of the company as annualized should be at least **50% of estimate cost** and liquid assets (LA) and /or evidence of access to or availability of credit facilities of not less than **15% of estimate cost.**
4. Original copy of Valid VAT Registration No, Excise Duty License, Service tax Registration, Manufacturer Certificate, Dealership Certificate whichever applicable.
5. Latest Income Tax & Sale Tax Clearance Certificate from the competent authority.
