**Eligibility Criteria:**

1. The bidder must be an individual firm having valid BIS certificate / preferably posses ISO 9001 certificate and having satisfactorily completed 2.5MVA, 33/11KV Power Sub Station, 33KV line, 11KV line, LT line & Distribution Sub Station or above class in last 7 (seven) years as on the date of bid opening and which must be in satisfactory operation for at least 2 (two) years as on the date of bid opening.  
Such certificate should be signed not below the rank of Executive Engineer.
2. Bidder must produce certificate having successfully completed RGGVY project in the state of Arunachal Pradesh.  
Such certificate should be signed not below the rank of Executive Engineer.
3. The average annual turn over of the bidders for the best three financial years out of last five (5) financial years of the company as annualized should be at least **50% of estimate cost** and liquid assets (LA) and /or evidence of access to or availability of credit facilities of not less than **15% of estimate cost**.
4. Valid VAT Registration under APGT Act 2005, Excise Duty License, Service tax Registration, Manufacturer Certificate, Dealership Certificate whichever applicable.
5. Latest Income Tax & Sale Tax Clearance Certificate from the competent authority.


