2. Prospective Bidder (s) shall furnish the following:
 - a. Original copy of the valid VAT Registration No., Excise Duty license, Service tax Registration (if any), manufacturer certificate, dealership certificate wherever applicable.
 - b. Latest Income Tax & Sale Tax, clearance certificate from the competent authority.
 - c. Documentary evidence that they have executed similar nature of work with equivalent amount in a single order commensuration to the tender packages being purchased in the last three years.
 - d. Experience certificate of having successfully supply & executed at least ten distribution substation of 11 KV class or above class, 6 Km of 11 KV HT & 3 Ph 5 wire LT line or above class in Hilly terrains of Arunachal Pradesh during the last 7 (seven) years as on the date of bid opening and which must be in satisfactory operation for atleast two (2) years as on the date of bid opening


