GENERAL INFORMATION AND BASIC QUALIFYING REQUIREMENTS:

1. Prospective Purchaser or Tender documents shall have to furnish letter of authority & proof of being an authorized representative of the Tenderer(s).
2. Prospective Tenderer(s) shall furnished the following:-
 - (i) Original copy of valid VAT registration No., Excise Duty, Electrical License, Service Tax Registration (if any), manufacturer certificate, and dealership certificate wherever applicable.
 - (ii) Latest income tax & sale tax clearance certificate and **Pan Card**, EPF Registration Certificate from competent authority.
 - (iii) Documentary evidence that they have executed similar nature of work with equivalent amount in a single order in the last five years in telecommunication, MES, NEEPCO, PGCIL, NHPC, CPWD, PWD, POWER & Railways.
 - (iv) Similar nature of works means completed "33KV, 11KV, LT Lines & Sub-Stations & Construction of Building works.
 - (v) The average annual turnover of the tenderers for the best three financial years out of last five financial years of the firm/company as annualized should be at least 50% of each tender value.
 - (vi) The tenderers shall have liquid assets (LA) and /or evidence of access to or availability of credit facilities of not less than 50% of turnover of each tender.
 - (vii) The contractors will have to produce documentary proof from the appropriate authority (which should be to the satisfaction of the competent authority) of having satisfactorily competed the similar works.
 - (viii) Joint venture, if any shall have to fulfill the terms & conditions at Sl.No.2(iv) above.
 - (ix) In any case of double handwriting shall deemed to be rejected by the authority.
3. Tenderer shall quote their rates as per terms and conditions of the said firm with upto date amendment, which will form part of the agreement.

Tender forms can be obtained from the office of the Executive Engineer(E), Seppa Electrical Division, Department of Power, East Kameng District, Seppa-790102, Arunachal Pradesh on all working days on submission of application and cost of tender Rs.2,500.00 (Rupees Two thousand Five Hundred) only by Demand Draft/Cash only forms upto 4.30 PM on 14.05.2015 Earnest money in the form of account payee Demand Draft or call deposit receipt of any schedule bank drawn in favour of the Executive Engineer(E), Seppa Electrical Division, Department of Power, Seppa payable at SBI Seppa should accompany in the sealed tender. The tender not accompanied with earnest money in prescribed forms shall be liable for rejection.
5. The Tender documents shall neither be sold nor accepted for opening through postal or courier services.
6. The Department shall not be responsible for delay in receiving any forms of the Tender document and not extension of time shall be entertained on such accounts. The Tender Documents received after due date of opening will not be accepted.
7. Department of Power reserve all right to cancel/withdraw the Tender in full or part without assigning any reason for such decision and to place order or full or in Part. Such decision will not incur any liability whatsoever on part of Department of Power Consequently.
8. Rate should be coated inclusive of all taxes & levies.
9. **Security Money shall be deposited through STDR/TDR of principal amount drawn on any nationalized Bank pledged in favour of Executive Engineer(E), Seppa Electrical Division, DoP, Seppa in the account of the contractor.**


