NOTICE INVITING TENDER FOR CLIENT MEMBERSHIP OF POWER EXCHANGE

On behalf of Governor of Arunachal Pradesh, the Chief Engineer(Power), Western Electrical Zone, Department of Power, Government of Arunachal Pradesh invites sealed tenders for Client membership of Power Exchanges (Indian Energy Exchange and Power Exchange of India Ltd.) from traders having valid Inter State Trading License issued by CERC and valid Membership certificate of both Power Exchanges to enable DoP, Arunachal Pradesh for Sale of power during surplus period through power exchanges. The details are as follows:

1. The bidders are requested to submit their tender as per Format at annexure-I.
2. Earnest Money Deposit (EMD) shall be in form of Bank Guarantee from a Nationalized Bank drawn in favour of Executive Engineer(E), Capital Electrical Division, Itanagar.
3. The Trading Margin should be quoted in Paise per KWH.
4. Trading Margin shall be FIRM basis (Inclusive of all taxes and professional charges) and there shall be no escalation during the contractual period.
5. The tender (containing envelopes for EMD and Bid) shall be accepted only if the cost of tender paper i.e. Rs. 5000/- (Rs. Five Thousand only) is submitted along with the tender.
6. Tender paper can be downloaded from DoP, AP web site www.arunachalpower.org.in. Tender received without Earnest Money, Valid inter-state trading license issued by CERC and valid membership certificate of both the power exchanges shall be rejected. The representative(s) of bidder present at the time of opening of the bid should be fully authorized for any clarification at the time of opening, if required.
7. Original and a photo copy of all related Licences/Certificates shall be submitted along with the bid documents for inspection. The Originals shall be returned immediately after the opening of the bids.
8. The Chief Engineer(Power), Western Electrical Zone, DoP, A.P. reserves the right to accept/reject any or all tenders without assigning any reason what so ever.
9. Telegraphic/Telex/faxed/e-mailed bids shall not be accepted.

General Terms & Conditions

1. The Earnest Money Deposit (EMD) shall be in form of Bank Guarantee from a Nationalized Bank drawn in favour of Executive Engineer(E), Capital Electrical Division, Itanagar.
2. The EMD of successful bidder shall be converted into 'performance guarantee' and shall be returned only after complete fulfillment of obligations under the contract. Hence, the Bank guarantee for EMD/Performance Gurantee must be valid upto 7th April 2017
3. EMD of unsuccessful bidders shall be returned within one week from the date of opening of the tender.
4. The successful bidder shall have to enter into an agreement with the Department of Power, Government of Arunachal Pradesh within one week from the date issue of award letter.
5. The contract period for client membership shall be 1st October, 2015 to 31st March 2017.
6. Trading Margin shall be FIRM basis (Inclusive of all taxes and professional charges) and there shall be no escalation during the contractual period.
7. The Payment against sale of power after deducting the trading margin shall be transferred to the Bank Account of the Executive Engineer(E) Capital Electrical Division, Itanagar on the same day of receipt of payment from power exchanges except on Bank holidays.
8. Delay payment surcharge @ 1.25% per month shall be levied on all unpaid dues.
9. Department of Power, Government of Arunachal Pradesh shall in no way be liable for any other charges.
10. Point of delivery of energy shall be Ex-bus bar of the project located in NE Region and of NTPC project at Eastern Region.
11. The Open Access approval/corridor, booking etc. shall be the responsibility of the successful bidder beyond delivery point. The payment of all charges related to Open Access shall made by the successful bidder.
12. All Transmission Losses, transmission charges, NLDC charges, RLDC charges, service charges etc. shall be born by the successful bidder.
