1. The bidder should possess registration in **class-III** category or above issued by the Electrical Inspectorate of Govt. of A.P/ Central Inspectorial organization of Govt. of India/ other state Govt.
2. Preference shall be given to Arunachal Pradesh District Based Entrepreneurs and Professionals (Incentives, Development and Promotional) as per guidelines issued by the Government of Arunachal Pradesh Notification dtd 13th April 2015 subjected to fulfillment of condition of above Sl. No. 1.
3. The bidder should submit Manufacturer's authorization certificate as per prescribed form for major items i.e (1) Steel Tubular Pole (2) ACSR Conductor and (3) Insulators.
4. Engraving of "**SADA-LDV**" on steel tubular poles is mandatory.
5. The Contractor should fulfill the criteria of satisfactory execution of work as given below:
