- Prospective purchaser of the bid document shall have to furnish letter of Authority & proof of being authorized representative of the bidder.
- 2. Prospective Bidder(s) shall furnished the following:-
  - Copy of the valid GST Registration Certificate, Manufacturer/Dealership Certificate wherever applicable.
  - Latest Income Tax & Sale Tax clearance certificate from the competent authority.
  - Documentary evidence that they have executed similar nature of work with equivalent amount in a single order commensurate to the tender package being purchased in the last three years. Experience Certificate to authenticate such execution from competent authority must be submitted
- 3. The application for tender documents accompanied with cost of bid document in Cash (Non Refundable) along with a set of attested copies of the above supporting documents has to be submitted to the following address:-

The participation in the tendering is restricted to the contractors domiciled in the territorial jurisdiction of Anjaw District as per Clause No. 05 of The Arunachal Pradesh District based Entrepreneurs and Professionals (Incentives, Development and Promotional) Act, 2015 notified vide SPWD/W-66/2012, dated 09/06/2015 and SPWD/W-66/2012/314, dated 13/08/2015. If the district based entrepreneurs and professionals who have got their firm already registered as contractors under Arunachal Pradesh Contractors Enlistment Rules 2008 but have the address different from their domiciled territorial jurisdiction, they shall be allowed to participate in the tender on production of proof of permanent residential certificate in support of their claim.
