**OFFICE ORDER**

In exercise of the provision of Automatic Annual Increment under Section – 3 of Schedule – III (SCHEDULE OF GENERAL CONDITIONS OF SUPPLY – 2006) of Tariff – 2006 notified vide Government's notification **NO.PWRS/W-256/95-96(Vol-II)/1756-67 dated 15<sup>th</sup> September 2006** and further approval of the Govt. to continue beyond 31/03/2011 vide **U. O. No. 818 dated 24/02/2011**, the Electricity Tariff under Schedule – I and Schedule of Miscellaneous Charges under Schedule – II have been enhanced by 5 % (Five percent) (rounded off to nearest 5 paise and nearest rupee respectively as under:-


